1. Match Winner

If one player withdraws (retires) or is disqualified after the first set has been completed, the player progressing to the next round or who is awarded the match by the umpire will be considered the winner. If the first set has not been completed, all Match Bets will be void.

If a match does not reach a natural conclusion, any markets (besides Match Betting) that are not unconditionally determined will be void.

In the event of a change to playing surface, venue or change from indoor court to outdoor and vice versa, all bets stand.

For betting purposes, the winner is always the player who is declared the winner by the match umpire and officially advances to the next round or is declared as winner of the tournament. The same applies to "Doubles" matches.

2. Set Betting

The full number of sets required to win the match must be completed. If a player is awarded the match prior to the full number of sets being completed, all correct set betting on that match will be void.

3. Current Set Winner (Live)

If a player retires from a match whilst a set is in progress but before the set has been completed, the set shall be deemed incomplete and stakes shall be returned.

4. Game by Game Betting (Live)

There are eight possible results for a game:

- Server wins to love
- Server wins to 15
- Server wins to 30
- Server wins to deuce
- Receiver wins to love
- Receiver wins to 15
- Receiver wins to 30
- Receiver wins to deuce

If a game is completed after an interruption for any reason, that game shall be deemed to be complete for betting purposes.

If a game is completed by the awarding of a penalty point by the umpire, the game shall be deemed complete. However if a game is completed by the awarding of a penalty game by the umpire, the game shall be void and all stakes shall be returned.

If a player retires from a match while a game is in progress but before that game has been completed, that game shall be deemed incomplete and all stakes shall be returned.

Bets on a game which subsequently becomes a tie break will be settled as void.

5. Total Games

Bets on the total number of games in a match will be over/under a particular number, e.g. 21.5 games.

In the event of a retirement, bets will be void unless at the time of the withdrawal the result of the total games is already determined e.g. If a match is abandoned at 6-4 4-4, bets on Over/Under 19.5 games or fewer in the match are settled as winners/losers respectively, since any conclusion to the match would have to have had at least 20 games. A champions tiebreak will count as 1 game for the purpose of total games bets.

6. Game Handicap Betting

The bet is based on the number of games each player wins in a given match, e.g. a player given a +2.5 game handicap who loses a match 7-6 7-6, would be the winner for handicap betting purposes.

In the event of a retirement, the same logic which shall apply to the total games in a set or match applies to handicap bets. For example, a player retires at 6-4 4-6 4-4; handicap bets of +/- 2.5 games would be settled as won/lost since neither player can win by more than 2 games. Bets on +/- 1.5 games would be void as the result is not determined. A champions tiebreak will count as 1 game for the purpose of game handicap bets.

7. Set Handicap Betting

The bet is based on the number of sets each player wins in a given match, e.g. a player given a +1.5 set handicap who loses a match 6-4 4-6 7-6 would be deemed the winner as they have covered the handicap.

In the event of a retirement or disqualification, bets will be void unless the result is already determined at the time of retirement.

A Champions Tie Break will count as 1 game for the purpose of Set Handicap Bets.

8. Retirements

Matches which cannot be played to their natural conclusion without unconditionally affecting the outcome of a bet will be settled in the event of a retirement (excluding Match Winner).

All bets that have been settled or are determined (i.e. the outcome is already decided) at the time a player retires are valid and will be settled accordingly (including cashed out bets). All bets that are not decided at the time a player retires shall be void.

Disqualifications are subject to the same settlement rules as retirements.

9. Set/Game/Tie-Break

A set/game/tie-break is deemed to have taken place as soon as its first ball has been played but the outcome of the set/game/tie-break is not decided before the set/game/tie-break is completed. If one point in a tie-break is played prior to a retirement/withdrawal, 'Will there be a tie break in the match' would be settled as 'Yes'.

10. Tie-Break

A tie-break is counted as one game for betting purposes. A set which finishes 7-6 is deemed to include 13 games, rather than 12 games + a tie-break.

If a match is decided by a "Match Tie-Break" instead of a final set, then the Match Tie-Break will count as a set for betting purposes.

For tennis matches that use the Match Tie-Break (in place of a final set), in the event that the next game turns out to be a Match Tie-Break, bets on the following markets will all be settled as void:

- Next Game Winner
- Next Game Score Betting
- Next Game Points
- Next Game to go to Deuce

If the next game is a regular game (i.e. not a Match Tie-Break) then bets will be settled as usual

11. To Win/Lose 1st Set and Win the Match

If either player withdraws from the match before the first set finishes, bets will be void. If the first set has been completed, the match part of the bet will be determined by the player awarded the match and bets will be settled.

12. Interrupted Matches

If a match is interrupted or postponed, the bets within the framework of the tournament will remain valid until the match is completed. An interruption or overnight suspension of a match is not grounds for a bet to be void.

13. Continued Matches (After a suspension of play)

In the case of interruptions, the continuation of the match can be offered, including the result at the time of the interruption. This continuation will be deemed a new match for betting purposes. In the case that a match is interrupted and not resumed, all bets on the continuation (including the result at the time of the interruption) of the match will be void.

14. Who will win/play more games in round X

The winner of a bet is the player who wins/plays the most games after comparing two players in the same round of a tournament. It is not important whether one of the two players wins or loses his/her match. For the purposes of this bet, only the games won/played by each player will be counted (a tie-break is counted as a game).

15. Team competitions (Davis Cup, Fed Cup, Hopman Cup, Laver Cup)

All bets on the winner of the team competition are valid as soon as the first ball of the first match is played. In the event of the retirement of one of the teams, the winner of the bet will be the team officially declared the winner by the respective governing body

Should a team withdraw before the first ball of the first match of the team competition has been played, all bets will be void.

16. Outright Betting/Quarter Betting/Half Betting

Should a participant take no part in the competition then bets on them will be void. Should they withdraw or be disqualified after the tournament begins, all bets will stand and will be settled as losers.

17. Winning Quarter/Winning Half

The tournament must be completed for bets to stand.

18. To Reach the Final

All-in, run or not (see outright betting).

19. Cash Out

All bets where 'cash out' has been accepted prior to a retirement will remain settled.

'Cash Out' is not guaranteed to be available for the entirety of a match (see specific cash out rules below).

20. Postponed Matches

If a match is postponed, your bet will stand providing the match is rescheduled to take place before the end of the Tournament.

Até onde você iria por amor proibido?

Essa é a pergunta que impulsiona a novela romântica negra **Medusa das Rosas**, de Navid Sinaki, ambientada no Irã moderno, onde o sexo entre homens é um crime capital. O romance é narrado por um jovem chamado Anjir e dirigido a seu amigo de infância e amor secreto, Zal. A ação começa com a desaparição de Zal após uma discussão entre os dois.

Uma extensão da prática artística de Sinaki

Antes de se dedicar à ficção, Sinaki teve uma carreira como artista visual, explorando a identidade queer junto com a mitologia grega e persa e formas desatualizadas de mídia digital e analógica. Essas obsessões não são esquecidas nubank bet 365 **Medusa das Rosas**; de fato, a novela pode ser considerada uma extensão da prática artística de Sinaki.

Anjir herdou de nubank bet 365 mãe, Nilofar, uma obsessão com mitos gregos e persas, especialmente com a figura do profeta cego Tiresias, que "se tornou uma mulher simplesmente por acertar dois cobras". Anjir acredita que também pode prever o futuro lendo chá. Em seguida, ele começa a questionar se também seria capaz de mudar de sexo: se se tornasse uma mulher, então ele e Zal poderiam ter seu "e alegremente para sempre". É uma peculiaridade do sistema iraniano que o governo está disposto a financiar cirurgias de redesignação de gênero, apesar de leis draconianas sobre sexo fora do casamento heterossexual.

Um clássico noir reimaginado

Zal é fã de filmes antigos de Hollywood, que assiste nubank bet 365 fitas VHS contrabandeadas com legendas nubank bet 365 persa desajeitadas. (No Irã pós-revolucionário, o consumo de cultura ocidental é rigorosamente controlado.) Uma trama para tirar a esposa de Zal do caminho é inspirada por *O Carteiro Traz sempre as Suas Cartas* - um toque metatextual de Sinaki, que

claramente está se divertindo escrevendo nubank bet 365 própria versão do clássico noir, repleto de sexo e violência e sociopatas.

Um romance que questiona os limites do amor

No entanto, **Medusa das Rosas** carece de um ingrediente essencial para um thriller: suspense. A intensidade do salto inicial da novela se dissipa gradualmente à medida que Anjir se distrai com várias tarefas: procurar Zal, tentar obter estrogênio, investigar se Zal o traiu, etc.

A grande questão é por que Anjir está disposto a ir a tais extremos para estar com Zal. "Nós éramos o primeiro de tudo uns dos outros", diz Anjir nubank bet 365 um ponto. "Que cruel encontrar amor na primeira tentativa." Nós apenas precisamos aceitar isso como uma história de amor para as idades.

Mas há muito pouco senso do que cada personagem é como e por que eles são atraídos um pelo outro: nenhum momento de interioridade, nem nenhuma interação significativa além de algumas cenas de sexo. Os melhores thrillers te colocam no centro das mentes e corações de seus anti-heróis (pense nubank bet 365 *O Talentoso Senhor Ripley* de Patrícia Highsmith). Você se importa o que acontece com eles - mesmo, ou especialmente, quando essa identificação tem implicações perturbadoras.

Talvez Sinaki não esteja visando escrever esse tipo de ficção. Em uma cena, Anjir e Nilofar estão discutindo o mito grego de Dido de Cartago, que se imolou depois de ser abandonada por Eneias - Anjir não entende por que alguém não tentaria automaticamente escapar de um incêndio.

"A mitologia não existe para o realismo", diz Nilofar. "Algumas fogueiras você não percebe que as fez." **Medusa das Rosas** também contém uma série de imagens e eventos superficialmente enigmáticos que têm uma ressonância alegórica mais profunda.
